2023 is the 22nd annual competition, excluding the COVID years 2020 and 2021.

The competition used to be named after His Honour Sir Rhys Davies KC, who was the Honorary Recorder of Manchester (senior resident criminal judge) until his early retirement in 2003. He was the first Honorary Recorder of Manchester who allowed the competition to take place. The trophy retains his name. However, this year the decision has been made to rename the competition after Paul Dockery who founded and ran the competition for over twenty years. His passion was not always just the law, but to enable others, from all walks of life, to find a way in to the law as a profession.

Further we are grateful to all the Judges for giving up a Saturday and agreeing to assess student's performances in the competition. They bring reality to the court appearance for all students and supporters.

This year we welcome one new school to the contest, Alderley Edge School for Girls. We wish them an enjoyable and successful stay in the competition.

The Competition would suffer if students did not have the opportunity to play their roles in real courtrooms and see the life of our local criminal courts at first-hand.
